There is a well-known story about a young man seen picking up starfish on the seashore and tossing them back into the ocean. When he was asked the reason for doing so, he replied that he wanted to save the starfish from being dehydrated when left on the shore. As there were thousands of starfish on the shore, anyone would have doubted the actual effectiveness of his action. However, the young man was undeterred and emphatically proclaimed that his small action would have mattered greatly to each starfish he helped.

This young man's belief and action epitomize what Salem Welfare Services (SWS) has been doing the past 25 years – to care and assist the elderly and the socially handicapped in their daily lives so that they can be uplifted to experience a better quality of life.

Although our financial means are limited, our desire to impact lives, even if it were a single life, is steadfast and unwavering. We want to be like that young man by the seashore, always looking out for a stranded starfish, and ever ready to lend a hand.

We, too, want to help and make a difference in each life that crosses our path.

The past couple of years have been extraordinary, dominated by unprecedented events like the Covid-19 pandemic and the war in Ukraine, that caused supply chain disruptions, resulting in shortages of food and fuel. As inflationary pressures are felt around the world, our communities have not been spared. Significant food price increases have hit everyone, but the live-alone seniors and needy families have been hit the hardest.

In line with Salem Welfare Services' vision to show kindness to the community; especially to the elderly, the needy persons and people with special needs, we decided to reach out to more communities beyond our original footprint in Yishun Central. d

Pursuant to this decision, we have, since 2019, set up an additional centre, known as the SWS Onesimus Village at Kebun Baru, whilst another centre is in the works, temporarily operating out of the premises of Salem Chapel in Thomson Hills Estate. In addition, the current Rehabilitation Centre for the Elderly at Yishun Central will also be restructured and its programme offerings enhanced in collaboration with St Luke's ElderCare.

We are thankful that SWS has never needed to walk alone since its inception 25 years ago. There have been countless people – volunteers, partners, donors and supporters who walked beside us, giving us words of encouragement, generously giving their time to serve the community at Yishun Central and Onesimus Garden at Neo Tiew, as well as sponsoring, through monetary support, the programmes of SWS and enabling us to augment our service offerings. Indeed, I like to echo Apostle Paul, as he said of the Philippian church, "Every time I think of you (all), I give thanks to my God" (NLT).

I am also grateful to the SWS Board and Management team — they are driven by love for the people they serve. I am humbled and inspired by their dedication and sincere care for our elderly, disadvantaged individuals and families. And I am certain that God, who began the good work in SWS, will continue His work until it is finished, according to His plan and purposes. •

God's Love Started It All 上帝的爱开始了这一切

t was 1997. It has been more than 20 years. In those days, digital cameras and smart phones were not available to record what we want to remember. Looking through the scant materials available, I managed to find some information I can use in this article. What I remember best is why Salem Welfare Services set up the Day Care and Rehabilitation Centre (Centre in short). Drafting out the Constitution, the verse I had selected to embody our passion was 1 John 4:19

- "We love because He (the Lord Jesus) first loved us". Our drive to show kindness and share God's love was what compelled the pioneers as they used their gifts and skills to plan. and establish the Rehab Centre in November 1995. It opened its doors at Block 323, Yishun Central in 1997 to serve the needs of the elderly in the Yishun area.

God brought together a Mrs Anna Liu at work group of people compelled Anna Liu 女士 by the love of Christ to

serve. The first Board of Directors comprised Professor Bay Boon Huat (Chair), Mrs Maureen Ng (Vice- Chair), Choong Shee Sai, Kelvin (Secretary), Daniel Wong (Treasurer), Ronnie Ong (Asst Treasurer), other directors responsible for special duties, fund raising, etc - the late Mr Lam Pin Shin, Mr Clarence Perera, Mr William Chan, Mr Wong Nam Hoi, Pastor Andrew Khoo, Mr Tan Chian Eng, the late Mr Eddy Winjadi and Pastor Neo Ban Hui. I am acknowledging them for their dedication. as pioneers.

Centre and writing the proposal for Ministry of Health's (MOH) approval, getting the Constitution approved, designing the space in collaboration with HDB, raising the funds to top up the subsidy from MOH, getting the key personnel to train staff and run the Centre were challenging. Nam Hoi looked into the nitty-gritty of housekeeping when the government granted the use of the double void decks at Block 323. Planning and constructing the void decks needed painstaking work to ensure compliance with MOH's and HDB requirements. Thank God, He provided all that were needed. For example, Professor Bay managed to engage the services of Mrs Anna Liu, the then retired Head of Physiotherapy at Singapore General Hospital. Being a Christian she was easily persuaded to join us. Professor Bay must have fired her enthusiasm with his own enthusiasm. Mrs Liu went on to serve at the Centre full time without pay for a few years. The Centre had credibility as a Rehabilitation Centre because of her standing in the physiotherapy community. She trained our staff and volunteers, planned the Centre's activities and offered internship training for students and aspiring physiotherapists. Her contact with other sister organisations and her expertise on the use and acquisition of equipment was a great blessing from God.

In the area of fundraising God favoured us. We had regular donations from the Lee Foundation as well as grants from the government's President's Charity Drive. Mr Clarence Perera organised many fundraising dinners and golf games. Church members gave willingly.

God gave us friends. Professor Ho Peng Kee, the then Senior Minister of State for Law and Home Affairs and Advisor to Nee Soon East Grassroots Organisations was Guest of Honour at the opening of our Centre in 1997. His support of the Centre helped us to use the grassroots organisation to disseminate our news and services to the wider community and paved the way for us to be an active part of the community. This collaboration was reported in The Business Times on 12 December 2007. Cycle & Carriage, Borneo Motors (C&C) had plans to donate a few vehicles to charity. The Centre had already booked a van and paid a deposit. However when Professor Ho approached C&C for help with the Centre's vehicular needs, the deposit was refunded and the Centre received a brand new van! Such was an example of how God moved people to come alongside us in this work.

As I flipped through the fundraising magazine - Seasons

of Love, published in 1999 as part of fundraising efforts, a articles caught my attention. They were written by Sis Tan Yit Wah and Brother Tan Chian Eng. Sister Tan was over 70 years old when she wrote the article. She mentioned: "As long as I have the strength, I will continue to volunteer my services to the Centre.. I find the work very satisfying". She's with the Lord now after being welcomed by her Lord and Saviour with "Well done, good and faithful servant. Enter into the joy of the Lord". Bro Tan was in his late 60s, having retired as principal of a primary school. He wrote: "As a Christian, I feel it is imperative for me to obey the teachings of the Bible. To me the commandment of Christ to love our neighbour as ourselves, is not only meant to be understood but to be practised as well".

We read of Paul's missionary journeys in the book of Acts and saw the leading of the Holy Spirit in the spread of the gospel. The Salem Day Care & Rehabilitation Centre was God leading us to show kindness and to share Christ. Pastor Andrew Khoo ministered to the users in the early years. He fulfilled his pastoral duty by engaging the elderly. Some even remembered his name fondly.

My ageing memory is at fault if I have left out anything or anybody important. I want to quote Paul in a Corinthians 35-7 - "What then is Apollos? What is Paul? Servants through whom you believed, as the Lord assigned to each. I planted, Apollos watered, but God gave the growth. So neither he who plants nor he who waters is anything, but only God who gives the growth". For those who knew Christ through the Centre, we can only glorify God who created for us the opportunities.

For all our activities for the elderly and organised for our neighbourhood, let us be mindful and intentional in sharing Christ. If we are not active or we have neglected God's call, be encouraged that our God is a God of 2⁸³ chances. Seize the opportunity to serve Him by getting involved. Our Current Activities

A gainst a rapidly evolving national landscape of the senior care sector in Singapore, Salem Welfare Services (SWS) carried out a review of our service portfolio in 2018. A vital focus of the review was to assess if SWS, particularly in the day-care component through its "Rehabilitation Centre for the Elderly" at Yishun, was effectively serving the needs of the community. As a result of the review, SWS decided to restructure itself to offer a new set of service propositions in Yishun, as well as create opportunities to offer the same in Kebun Baru at Ang Mo Kio and Thomson Hills Estate.

At present, "SWS Onesimus Village at Kebun Baru" runs four programmes at its Block 113 centre while the Onesimus Village at Thomson Hills Estate (temporarily operating out of the premises of Salem Chapel church) presently runs only the Dementia and Caregiver programme.

Dementia and Caregiver Programme



This programme is also called the Meeting Centre Support Programme (MCSP). It provides a community-based social, emotional and practical support for people living with dementia and their family caregivers to adjust to the gradual changes that a person living with dementia undergoes. The first objective is to help family caregivers to become more competent to provide care to their loved ones and building a community of support for them. The second objective is to help the persons living with dementia to be more active through the various activities and thereafter, hopefully, develop new friendships through the MCSP.

Community Programme

The services include:

- providing a communal space for seniors through a community cafe to socialise with their peers and find social support
- organizing "active ageing" activities such as morning exercises, arts and crafts, Chinese calligraphy writing and table games.
- community befriending





Food Distribution and Outreach Programme

Staff and volunteers distribute fresh vegetables weekly and essential food and groceries' monthly, to families in need and to the seniors who live alone in Block 115 of Kebun Baru Estate. On ad-hoc occasions, generous sponsors would supply additional cooked meals in lunch boxes, and SWS is then able to distribute to a wider network of seniors living in neighbouring HDB blocks as well.

Inclusive Dementia and Assisted Living (IDeAL) Programme

SWS is collaborating with the Kebun Baru Grassroots Organisation to build an inclusive and dementia-friendly community where people living with dementia and their caregivers are socially and emotionally supported while living in the constituency. Under this programme we provide befriending and visitation services to seniors living alone in the rental HDB block 115 in Kebun Baru estate. HDB block 115, has been identified as an "Assisted Living" block where the seniors have opted to "age in place". SWS volunteers are part of a team that chaperon seniors for medical appointment at the hospital and polyclinic.

Additional services we provide under this Programme include:

- monitoring key "health indicators" such as blood pressure, heart rate and blood glucose level to support the hospital healthcare system in executing medical care plans for seniors with declining health. (The information is then submitted to a consolidated database where they are monitored and evaluated by medical care staff).
- providing fresh vegetables to the central kitchen where lunches are prepared onsite daily for the seniors living in the HDB block.
- fortnightly morning exercise designed for the seniors to strengthen their body.



Programme Feature:

Dementin and Caregiver Programme

The programme is an intensive 2-hour engagement with the people living with dementia that includes exercise and movement, tabletop games, cognitive stimulation activities such as "Art and Reminiscence" type activities.

Social support is also given to the Caregivers through separate monthly group discussions, whereby caregiving techniques are imparted. Mutual sharing among the Caregivers during such sessions also allows them to learn from one another.
